Administration of interviews include collection of physical health data and interviews required to meet grant requirements. Collection of physical health data includes checking and recording the consumer's pulse, blood pressure, temperature, weight, height, and other medical history data as required. In addition to written materials, consumers with low or medium health literacy will be assisted through the use of Teach Back to provide training and support. RN: Ensure that an annual nursing assessment, located in SENTRI 2, is administered annually for adults with Serious Mental Illnesses and children with Social Emotional Disorders. Collection of physical health data includes checking and recording the consumer's pulse, blood pressure, temperature, weight, height, review of primary care and specialist provider appointments and other medical history data as required. Adult, Child	150 units per year	<p><b>LPN/MA/RN:</b> Assure at least the top three medical concerns of each consumer is listed in the consumer electronic health record (EHR= Sentri 2). This information will be confirmed with the primary care provider and entered into SENTRI 2 EHR. Follow up on SCCMHA identified "at risk" or "high risk consumer populations" (adults with serious mental illnesses and children with Social Emotional Disorders) provided to each provider treatment team. This will include Care Alerts i.e. notification of labs and other consumer health monitoring items that are due. Perform screenings for depression, suicide and health literacy. Record screening results.</p> <p><b>RN:</b> In conjunction with case holders, complete the process of 9 Touch for transition of care e.g., post hospital discharge or post extended care facility discharge back to consumer community or residential living arrangement. Complete a medication reconciliation, which can only be completed by a nurse. Medication Reconciliation is required for each transition of care and at least annually for consumers who are eligible for services from SCCMHA. This consists of contacting all prescribers of medications, including physical health care providers, to assure proper dosages, and comparing to what the client has reported as their prescriptions.</p>	LPN/MA documents notes in the Chart Note section of SENTRI.
