# **III. OVERVIEW OF SUPPORT COORDINATION & SELF DETERMINATION**

Charlotte Fondren / Kalen Steger gave an overview of Support Coordination & Self Determination. The following was noted in the presentation:

- Support Coordination helps individuals with intellectual and developmental disabilities (ID/D) and provides linking / coordinating of services, AFC placement, includes behavioral services team as well
- Caseholders see consumers based on level of need (everything from weekly to quarterly)
- Self Determination can come into assist individuals either in their own home or in apartment
- Persons served decided from, who, when services are provided (i.e. self directed)
- Originally it was for folks 18+ but now available for everyone
- Community Living Supports (CLS) individual to learn new skills
- Respite Primary care giver a break
- Options include: programming from Heart of the City, Place for Grace, Ready for Life, among others
- 57 Children, 74 referrals already this year (79 total referrals from last year)
- 175 Adults at present
