I. CALL TO ORDER

Ann Finta, Chair called the meeting to order at 6:00 p.m. Verification of the public posting was acknowledged and a quorum was established.

Ann welcomed everyone to tonight's meeting. Review and Acceptance of the Minutes of June 6, 2024.

II. CONTINUING EDUCATION DEPARTMENT UPDATE

Alecia Schabel presented an update on SCCMHA's Continuing Education Unit (CEU). The following was noted:

- The SCCMHA Continuing Education Department is responsible for providing and supporting MDHHS training requirements for the entire network of around 1900 providers
 - CEU provides in-house training for 95% of MDHHS training requirements, vs. using external sources
 - Requirements for all staff such as: Recipient Rights, Bloodborne Pathogens, Limited English Proficiency, Health Care Compliance etc.
 - And requirements for clinical providers such as: Interviewing skills, screening & assessment skills and treatment planning and Individual Plan of Service development, Evidence Based Practice
- 7 CEU staff work in the unit
 - 3 trainers including Alecia Schabel, Supervisor
 - Trainings are held 17-18 days out of the 18-19 calandar days in a training month (regular office hours M-F)
 - Facilitate both in-person and virtual training option
 - 4 administrative staff
 - Training Registration
 - Data Entry
 - Monthly/Quarterly Training Compliance Reporting to individual providers

- Training Calendar Maintenance
- Training coordination: creating training announcements and supporting sessions
- Classroom set up
- CEU provides around 114 required clinical trainings annually
 - Around 250 clinical providers trained in 2023
 - Annually, clinical staff have the opportunity to acquire over 300 Social Work CEs for licensure, around 150 MCBAP credits for Substance Use providers & over 250 Child Diagnostic credits for providers who work with children
 - 15 SCCMHA Clinical trainings are offered at a reduced cost to Community Professionals/Social Workers in settings like schools, hospitals, the Saginaw Co. Court staff, human service outreach Agencies, etc.
- CEU provides 223 Direct Care Staff /AFC courses
 - Around 500 direct care staff trained in 2023
 - We host annual New Home Manager training to support new AFC Home Managers orientation to their new role / 10-15 new managers each year
 - \circ $\,$ We also host an annual renewal Home Manager training to continue supporting AFC Homes $\,$
 - Managers also provided with any new MDHHS, updates/requirements / 45-50 each year
- CEU also provides training for community members: Mental Health First Aid
 - 14 courses offered in 3 different modules: Youth, Adult and Public Safety
 - 134 people in the community trained in MHFA in 2023
 - Recently added the MHFA Veterans Module
 - Veteran & Military Family Navigator is the main instructor for this course
- Upon request, CEU will provide some general Mental Health education to community agencies.
 - STARS often partners with SCCMHA for a Working with People training to better equip their drivers when transporting persons served

- Who are we credentialing? Physicians, PAs, Psychologists, MSWs, LLMSWs, Social Services Techs, NPs, Registered Nurses, Licensed PNs, OTs, OT Aids, PTs, PT Assistants, Speech Pathologists, BCBAs, and other Masters prepared therapists, etc.
