II. COMMUNITY TIES PROGRAM PERFORMANCE SURVEY RESULTS Charlotte Fondren, Director of Services for Persons with Intellectual and Developmental Disability presented the recent 2023 Community Ties Program Performance Survey Report. The following was noted:

- Community Ties Program supports consumers as they experience community integration as per Home and Community Bases Services (HCBS) standards through daily opportunities provided by these programs for meaningful activities, exercising choice, and building relationships and community partnerships.
- Review of Survey Results:
 - 86 Surveys distributed to guardians, consumers, AFC homes, Support Coordinators, Occupational Therapists, and Supervisors for those who attended CTN and CTS distributed 71 surveys to those participating. Of the 157 program surveys distributed, 79 were completed (52%).
- Charlotte explained that the next step would be the formulation of Quality Improvement Plans for areas of concern.

 Survey Results were reviewed as well as Comments by those completing surveys. (350 surveys were sent and 73 returned – 21%)
