VI. OTHER ITEMS OF IMPORTANCE

 Early Childhood (Baby) Court Program will be developing in Saginaw County at the 10th Circuit Family Court on Hospital Road. MDHHS selected Saginaw County along with St. Clair County for expansion funding to support this new specialty court development.

Sandy and MDHHS officials participated in a recent virtual interview with WNEM about the implementation of the Early Childhood Court. Last week, she was interviewed at Family Court by ABC -12 along with Judge Barb Meter and Jennifer Shores, Dir. of the local DHHS Office. SCCMHA is receiving MDHHS HRSA grant dollars to support our hire of a new senior clinician to serve as the Court Coordinator for this new specialty docket. SCCMHA has hired a new staff member to serve as the Court Coordinator and she will begin at SCCMHA on May 20th.

Saginaw Medical Diamond Project revealed.
Last Monday night 200+ people representing the leadership of the Saginaw community were at Horizons for the reveal of the Saginaw Medical Diamond Master Plan for development on Washington Ave. Architects that designed the Master Plan, spoke to the attendees about their vision for the development. The site development is anchored by a new building for the relocation of the CMMU Medical School from Mt. Pleasant. Other buildings include one for SVSU and another for Saginaw Public Health and a Behavioral Health Clinic. The plan is for the site to serve as a multidiscipline healthcare teaching/learning hub.
